THE ASSOCIATION OF AFRICAN OLYMPIC SPORTS CONFEDERATIONS (CASOL) SEES LIGHT OF DAY IN YAOUNDE, CAMEROON

The Association of African Olympic Sports Confederations (CASOL) was established in Yaounde, Cameroon, on 13 October 2024, at the Mont Fébé Hotel, following the constituent General Assembly of the new body. Its pioneer President, Mr Hamad Kalkaba Malboum, President of the Confederation of African Athletics (CAA), heads a nine-member Executive Committee tasked with laying the groundwork for the new structure.



he Association of African Olympic Sports Confederations (CASOL) was established in Yaounde, Cameroon, on 13 October 2024, at the Mont Fébé Hotel. This followed deliberations of a General Assembly, the first of its kind, which was convened at the behest of the following three confederations and their presidents: the Confederation of African Athletics. represented by its President Mr Hamad KALKABA MALBOUM, the Confederation of African Canoeing-kayaking, represented by its President Mr Joao Manuel DA COSTA ALEGRE AFONSO and the African Fencing Confederation, represented by its President Mr MBAGNIK NDIAYE.

The solemn Constituent Assembly was attended by 25 of the 32 existing Olympic sports confederations, with the prominent presence of IOC members in Africa and the ANOCA Executive Committee led by ANOCA President and ANOC Vice President, Mustapha Berraf. Also worthy of note was the presence of Mr Mehrez Boussayene, in his capacity as an IOC member, member of the Legal Affairs Commission and ANOCA Legal Affairs Commission, Chair. Mr Boussayene saw to it that this new African sports governing body, which aims to defend the rights and interests of African athletes and ensure that the African Games serve as qualifiers for the Olympic Games, was in compliance with the rules governing the creation of such associations both in terms of substance and form.



Deliberations were conducted in a convivial atmosphere where commitment, responsibility, mutual understanding, constructive dialogue and perfect cordiality prevailed, and indication that the entire African Olympic and sports movement has taken a significant step forward on the path to progress.

The creation of this new sports association marks a new dawn for the African Olympic Movement. The event comes at a critical moment, following hard on the heels of the Olympic Games Paris 2024, and symbolises the desire of the African Olympic Movement and ANOCA to work for a united sporting Africa, determined to overcome the many challenges on its way to emancipation. Hence the clarion call for unity from the ANOCA President: "Today, I would like to appeal to you, great dignitaries, to ensure that we always work together, hand in glove, to defend the exceptional potential of our continent. Together we will overcome! Together we will succeed".

President Mustapha Berraf then insisted on the unity and development of the African Olympic movement, which he is promoting and advocating for it to be strengthened: "For my part, I would like to confirm that our objectives, the objectives of our meetings, which will certainly be many, have no other aim than to consolidate our UNITY and also to reflect on the future of our various Olympic sports in order to obtain the right not only to exist but also to promote our athletes, our coaches and our leaders at the international level. To this end, we must, together, step up efforts to ensure that the AFRICAN GAMES become Olympic qualifiers from 2027 onwards, because they cannot be limited to just our

One of the highlights of the constituent General Assembly of CASOL was the election of Hamad Kalkaba Malboum. President of the Cameroon National Olympic and Sports Committee (CNOSC), as pioneer President of the new Association, who said he was: "... delighted to have been unanimously chosen by the members of this General Assembly, made up of the

promotion of Olympic sports in Africa. This new entity is designed to harness the efforts of African sports confederations in the organisation of Olympic qualifiers and competitions, while promoting coordination with the International Olympic Committee (IOC).

Suffice it to note that, until now, the organisation of Olympic Games qualifiers for African athletes has been fragmented between various sports confederations. With the creation of CASOL, the aim is not only to centralise these efforts, but also to strengthen Africa's place on the world sporting stage. CASOL will thus play a crucial role in the preparation of African athletes and in the management of results and performances during the Olympic Games.

As the pioneer President of CASOL, and on the strength of the unanimous support for his nomination, Kalkaba Malboum embodies the hope and the future of Olympic sports in Africa. He will have many challenges to rise to, including promoting the performance of African athletes, improving sports infrastructure on the continent and fostering Olympic values.

Besides the President's roadmap, CASOL still faces a number of challenges, notably the development of modern infrastructure, funding of sports federations and the training of budding talents. CASOL will also have to work for a more even distribution of resources and opportunities across the various regions of the continent. The aim here is to encourage the emergence of new talents and enable African athletes of all disciplines to shine at the Olympic Games.






Another major challenge will be to strengthen cooperation with other sports confederations and the IOC, to help African athletes qualify in a greater number of disciplines. This will also involve developing both sports and academic support programmes for athletes, for the overall development of Africa's young sportsmen and women. In addition, CASOL will have to quickly convince its hierarchical governing body, the Association of Summer Olympic International Federations (ASOIF), to put in place new qualification protocols for the Olympic Games that are favourable to African athletes.

CASOL's mission is therefore clear: to unite, promote and support its members, the African sports confederations, while preserving their autonomy and safeguarding their common interests and goals vis-à-vis the International Olympic Committee (IOC), the Association of Summer Olympic International Sports Federations (ASOIF), the Association of National Olympic Committees of Africa (ANOCA), governments, intergovernmental organisations and any other relevant organisation.

At the end of the meeting, financial support was announced by ANOCA, which also officially recognised CASOL. This support is crucial for the operation and governance of the new association. Following this event, the new Executive Committee met with Cameroon's Minister of Sport and Physical Education, Professor Narcisse MOUELLE KOMBI, who, on behalf of the government, welcomed the initiative and pledged the Cameroon government's multi-faceted support for all CASOL initiatives.

On 13 October 2024, the Executive Committee of the Association of African Olympic Sports Confederations (Casol) met for its first session chaired by its new President, Hamad Kalkaba Malboum.

his first meeting afforded the ten appointed members the opportunity to address a number of concerns: the immediate need for the constituent General Assembly to adopt the CASOL Constitution; the urgent need to reflect on the implementation of an action plan, a strategic plan and a funding policy for the activities of the Association of African Olympic Sports Confederations (CASOL).

It entails also working to ensure that the African Olympic Movement organises the 2027 African Games in Cairo. The President was also mandated to set up an administration in Yaounde and to initiate discussions with the Government of the Republic of Cameroon to obtain its support, particularly with regard to a headquarters

agreement and the provision of a building to house the offices of the new association.

The President opened the meeting by thanking the Executive Board members for having once more accepted to serve the African Olympic Movement. He also congratulated them on the confidence bestowed on them by the Constituent General Assembly of the Association of African Olympic Sports Confederations (CASOL).

The Executive Board thereafter addressed issues relating to the main mission of CASOL, which is to eliminate all obstacles to the qualification process of African sportsmen and women for the Olympic Games, by engaging in constructive discussions with the International



Federations, the Association of Summer Olympic International Federations (ASOIF) and the International Olympic Committee. A roadmap will also be drawn up in the next three months, in a bid to get IOC and ASOIF recognition. The Executive Board

has six months to draw up and present a strategic plan to the General Assembly.

It is on this note that the curtains were drawn on the first CASOL Executive Board meeting.

By initiating this consultation, you have chosen to hold strong with efficiency for the success of our athletes in major global sporting events.

Ladies and gentlemen, I know your intention is to strengthen the African Olympic Movement. It is a lofty goal, the task quite challenging. Ensure that the actions you wish to implement are a glowing example.

Learn to give added value to the actions you wish to undertake. Work together to place the African athlete at the centre of your concerns. As true pan-Africanists, be mindful to give Africa a soul.

Be bold and proud to chart a course for Olympism on our continent. The greatest challenge you will constantly face is to galvanise forces and garner the enthusiasm to do better.


I have high hopes for the success of these deliberations, for it is in standing together that we must present to the world a united front of Men committed to the values that govern Olympism.

It is on this note of optimism that I declare open the deliberations that have brought you together here in Yaounde.



I am delighted to have been unanimously chosen by the members of this General Assembly, made up of presidents of African Olympic Sports Confederations, 25 of the 28 are here present. We will work to ensure that the process of qualifying African athletes for the Olympic Games is reviewed, in conjunction with the Association of Olympic International Federations, which organises the qualification process, so that Africa does not suffer from the current schedule, which sends its athletes all over the world to vie for an uncertainly qualification.

All participants in this consultation, which started as a consultation and later became a constituent General Assembly and then an elective General Assembly, thought that I had the profile, given my experience and seniority as a Confederation President, but also as President of a major sport, particularly at the Olympic Games on behalf of Africa. They have placed their trust in me, and I am going to share that trust with a committee that has been set up, made up of ten members from each of the Olympic sports that concern us. So, it's with the committee that we're going to identify the right strategies to propose to the General Assembly, so that the Assembly can approve a development plan for our Olympic movement, with a view to giving African athletes more than what they've had in the past.

We are partners (CASOL and ANOCA). ANOCA is an association of national Olympic committees, in other words the decentralised arm of the International Olympic Committee. We are a continental organisation linked to the Association of Olympic International Federations, which qualifies athletes, organises competitions during the Olympic Games, announces the results and receives a dividend from the proceeds of the Olympic Games. We believe that, by being the continental counterpart, we can benefit from new resources to develop our sport.





ANOCA President, IOC Member



Greetings to our Cameroonian brothers and sisters! Greetings to all the officials! I wish, first and foremost, to thank the Cameroon government and all its components: the Sports Minister, the Minister of Labour and the National Olympic Committee, who have made exceptional efforts to host this major event. I would like to highlight the legendary hospitality that is always the hallmark of Cameroon.

I'd like to remind everyone of the objectives of this high-level meeting, which is to ensure that, in the future, we can assert our rights and make our voices heard, especially internationally. We realised that in most of the sports disciplines, an athlete has to travel almost round the world to qualify for the Olympic Games, and obtain some points, etc. And we are now convinced that the African Games must become Olympic Games qualifiers.

This couldn't have been done without the support of the broader Olympic Movement, and the International Olympic Committee, which welcomed this initiative, to enable our federations, most of them with limited means, to avoid spending huge sums on travelling and flight tickets for their athletes to qualify. So, I think that today, the massive participation of the majority, that is 25 African Olympic confederations attending this event in Yaounde, is to be saluted.

"Yaounde will once more be a key element in the future of African sport and, by extension, world sport. I think that the unity that you have observed here today, the words of fraternity and common sense, and the medium- and long-term vision of the Minister, have been very well received by the entire sporting community. And I believe that, today, we have clearly understood that we must be at the service of all, at the service of African athletes, and no longer put personal interests at the forefront.





MINUTES OF THE CONSTITUENT GENERAL ASSEMBLY HELD IN YAOUNDE, MONT FEBE HOTEL ON 13 OCTOBER 2024 AT 11.00 A.M.

The deliberations of the Constituent General Assembly, attended by the 25 confederations and dignitaries from the African Olympic movement including ANOCA President, Mustapha Berraf, concluded with a number of decisions and resolutions. These included the unanimous appointment of the Chair of the Constituent General Assembly, who immediately tabled for adoption a number of resolutions, such as the creation of the Association of African Olympic Sports Confederations (CASOL), the election by acclamation of its pioneer President, and the election of the other nine members of the CASOL Executive Board.

The Constituent General Assembly of the Association of African Sports Confederations hereinafter "African Olympic Sports Confederations" took place on 13 October 2024 as from 11.00 a.m., at Mont Fébé Hotel Yaounde, Cameroon. The meeting was convened at the behest of the following African Sports Confederations:

- Confederation of African Athletics, represented by its President Mr Hamad KALKABA MALBOUM;
- The Confederation of African Canoeing-kayaking, represented by its President Mr Joao Manuel DA COSTA ALEGRE AFONSO;

The General Assembly unanimously appointed **Mr Hamad KALKABA MALBOUM**, who accepted, Chair of this Constituent General Assembly, and **Mr João Manuel DA COSTA ALEGRE AFONSO**, who accepted to be the Secretary of the session.

Taking the floor, the Chair thanked all those present for the trust placed in him.

He then requested the Secretary to verify the quorum. Following the roll call, he announced that 25 of the 34 African Sports Confederations were present.

The quorum was thus reached, and the Chairman declared the session open.

The Chairman pointed out that this meeting was holding at a decisive moment in the life of the African Olympic Movement, with the aim to establish an association of African Sports Confederations to defend the rights and interests of African athletes and make the African Games qualifiers for the Olympic Games.

This new Association will make this task easier by acting as the sole representative of all African Sports Confederations before the IOC, ANOCA, ASOIF, the African Union and any other authority or body connected with the Olympic Movement.



The Chairman then tabled the following agenda to the meeting:

- Validity of the Meeting and approval of its agenda;
- Establishment of the Association of African Sports Confederations;

3) Discussion and approval of the draft Constitution and Logo of the Association of African Sports Confederations;

- Election of the pioneer President of the Association of African Sports Confederations:
- Election of the nine pioneer members of the Executive Board of the Association of African Sports Confederations;
- Procedures and Powers.

The Chairman then tabled the draft Constitution of the Association of African Sports Confederations to the General Assembly for discussion and adoption pursuant to the resolutions of the consultative meeting of the African Movement held on 12 October 2024 and attended by the same dignitaries present today.

After discussion, the Chairman of the meeting put the following resolutions to the vote:

RESOLUTION 1: Validity of the Meeting and approval of its agenda

The General Assembly approved and adopted the holding of this Constituent General Assembly as regards its form;

Put to the vote, this resolution was unanimously adopted.

RESOLUTION 2: Establishment of the Association of African Sports Confederations

The General Assembly resolved to create the Association of African Sports Confederations to be the only representative before the IOC, ANOCA, ASOIF, the African Union and any other authority or body in connection with the Olympic Movement.

Put to the vote, this resolution was unanimously adopted.

RESOLUTION 3: Discussion and approval of the draft Constitution and Logo of the Association of African Sports Confederations

The General Assembly, after reading the draft Constitution and amendments thereto, decided to approve the final wording of the said Constitution and adopted the LOGO presented, Design 1 in green.

Put to the vote, this resolution was unanimously adopted.



RESOLUTION 4: Election of the Pioneer President

Mr Hamad KALKABA MALBOUM, nominated by the General Assembly for the position of President of the Association of African Sports Confederations, was elected pursuant to the provisions of paragraphs 5 (3) and 4 (14) of the Constitution by a show of hands and unanimously by those present.

Put to the vote, this resolution was unanimously adopted.

RESOLUTION 5: Election of the other pioneer nine members of the Executive Committee

Given that the General Assembly proposed 9 (nine) other members to occupy the 9 (nine) seats on the Executive Board, the said General Assembly, in accordance with the provisions of paragraphs 5 (3) and 4 (14) of the Constitution, unanimously elected by a show of hand the following other persons as members of the Executive Board:
